#### 2. Review of December 2019 Financial Report

Edward DesPlas reviewed the Operating Budget Report for December 31, 2010 with the Trustees.

#### 3. Tuition Rate - Fiscal Year 2021

Discussion of the credit tuition rates occurred. Recommendations will be made at the March Board Meeting to increase resident rates by \$3.00/credit hour and non-resident rates by \$9.00/credit hour.

#### 4. Budget and Financial Outlook

The Budget and Financial Outlook for Fiscal Year 2021 was reviewed with the Trustees and discussion occurred on the following topics:

- Credit enrollment projected to go up by 1%.
- Tuition rate increase recommendation.
- Property values and resulting property tax revenue projections.
- Oil and gas production tax revenue projections looking to go down by 30%.
- State funding conservatively projected to go up by 1.6%

• The State considerations of an appropriation to fund a pay increase for full-time employees amounting to 2% or 3%.
