#### 2. January 2021 Operating Budget

The Operating Budget for the seven months ended January 31, 2021 was presented to the Trustees by Edward DesPlas. He reported that January 31, 2021 ended well due to the CRRSAA or CARES II funding.

- 3. FY 2021-2022 Revenue Projections Budget Development and Multi-Year Outlook
  The 2022 Revenue Projections and the Multi-Year Outlook were discussed. The
  cloudiness in FY 2022's "crystal ball" is beginning to clear. The College anticipates more
  resources in FY 2020; however, SJC will not recover all of the state funding or
  enrollments (Tuition & Fee revenue) lost in the current year reported Edward DesPlas.
- 4. Discussion: Change of May Board Meeting Date to Approve FY 2022 Budget and FY 2021 Year-End Budget

Because of the Board-approved FY 2020 Budget and the Board-approved Year-End Revision to the FY 2021 Budget are to be submitted to the Higher Education Department no later than May 1, 2021, the Board discussed moving its May 4, 2021, meeting into the last week of April.

#### 5. CARES Institutional Grant and CRRSAA Grant

Edward DesPlas briefed the Trustees on the CARES and CRRSAA Institutional grant. Effective January 15, 2021, CRRSAA increased the College's \$1,368,584 CARES Institutional grant by \$4,814,009 and substantially expanded the ways in which the COVID-19 relief funds may be used. The positive impact on SJC is significant and provides the College with some strategic opportunities.

### 6. Pathways Update

Dr. Forgette updated the Trustees on the good things happening with the Pathways efforts.

## 7. Student Housing Update

The update on student housing focused on the construction timeline.
