____ **A. Student Funds**

____ **B. Family or Friends**

A sponsor’s statement and bank documents are required of all sponsors. The sponsor statement should include the following:

- A statement that the sponsor will financially support the student
- Student’s name
- Sponsor’s name
- Sponsor’s signature and date

The sponsor must submit one or more of these documents to equal the required funds:

- Bank statement for checking, savings and/or other accessible bank account
 - Certificates of deposit; mutual, stock or bonds funds; and/or other accessible funds
- *U.S. sponsor must complete form I-132

____ **C. Private Company**

The following items will be required:

- A statement on company letterhead verifying that the business will financially support the student. The statement should include the student’s name and the responsible official’s signature
- A bank letter showing name of sponsor as an account holder for the business.
- Bank statement(s) of Certificates of deposit; mutual, stock or bond funds; and/or other accessible funds

____ **D. Government**

An official letter of sponsorship signed by the appropriate government official is required.
